Annex: Definition of IFRA Classes

IFRA Class 1 – Lip products of all types (solid and liquid lipsticks, balms, etc.); Children's toys.

IFRA Class 2 – Body sprays (including body mist); Deodorant and antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm, deo-cologne, etc.).

IFRA Class 3 – Body and face paint (for children and adults); Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, etc.) including eye care and moisturizer; Facial make-up and foundation; Facial masks for face and around the eyes; Make-up remover for face and eyes; Nose pore strips; Wipes or refreshing tissues for face, neck, hands, body.

IFRA Class 4 – Products related to fine fragrance: hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragrancing cream, etc.); Fragranced bracelets; Aftershaves of all types (except creams and balms); Ingredients of perfume kits and fragrance mixtures; Scent pads, foil packs; Scent strips for hydroalcoholic products.

IFRA Class 5A – All powders and talc (excluding baby powders and talc); Body creams, oils, lotions of all types; Foot care products (creams and powders); Insect repellent (intended to be applied to the skin).

IFRA Class 5B – Facial moisturizers and creams (including care products for beard and mustache); Facial toner.

IFRA Class 5C – Hand cream; Hand sanitizers; Nail care products including cuticle creams, nail lacquer remover, etc.

IFRA Class 5D – Baby cream/lotion, baby oil, baby powders and talc.

IFRA Class 6 – Products with oral and lip exposure: toothpaste; mouthwash, including breath sprays; toothpowder, strips, mouthwash tablets.

IFRA Class 7A – Rinse-off products applied to hair with hand contact: hair permanent or other chemical treatments (rinse-off) (e.g. relaxers), including rinse-off hair dyes.

IFRA Class 7B – Hair deodorizer, hair perfume; Hair permanent or other hair chemical treatments (leave-on) (e.g. relaxers), including leave-on hair dyes; Hair sprays of all types (pumps, aerosol sprays, etc.); Hair styling aids non-sprays (mousse, gels, leave-on conditioners); Shampoo – Dry (waterless shampoo).

IFRA Class 8 – Baby wipes; Intimate deodorant spray; Intimate wipes; Tampons; Toilet paper (wet).

IFRA Class 9 – Rinse-off products with body and hand exposure: bar soap; shampoo of all types; cleanser for face; conditioner; liquid soap; body washes and shower gels of all types; baby wash, bath, shampoo; bath gels, foams, mousses, salts, oils and other products added to bathwater; foot care products (feet are placed in a bath for soaking); shaving creams of all types (stick, gels, foams, etc.); all depilatories (including facial) and waxes for mechanical hair removal; pet shampoo.

IFRA Class 10A – Household care products with hand contact (excluding aerosols/sprays): hand wash laundry detergent (including concentrates); laundry pre-treatment of all types; hand dishwashing detergent (including concentrates); hard surface cleaners of all types; machine laundry detergents with skin contact; fabric softeners of all types excluding fabric softener sheets; household cleaning products, other types; floor wax; fragranced oil for lamp ring, reed diffusers, pot-pourri, liquid refills for air fresheners, etc.; ironing water.

IFRA Class 10B – Household care aerosol/spray products: animal sprays – applied to animals of all types; air freshener sprays, manual, including aerosol and pump; aerosol/spray insecticides.

IFRA Class 11A – Feminine hygiene conventional pads, liners, interlabial pads; diapers (baby and adult); adult incontinence pant, pad; toilet paper (dry).

IFRA Class 11B – Facial masks (paper/protective) e.g. surgical masks not used as medical device; facial tissues (dry tissues); fertilizers, solid (pellet or powder); napkins; paper towels; pillow spray; scented socks, gloves; tights with moisturizers.

IFRA Class 12 – Air delivery systems; automated air fresheners and fragrancing of all types; candles of all types (including encased); cat litter; deodorizers/maskers not intended for skin contact; dishwash detergent and deodorizers for machine wash; dry sheets and fabric softener sheets; fuels; insecticides (excluding aerosols/sprays); joss sticks or incense sticks; laundry detergents for machine wash with minimal skin contact; paints; plastic articles (excluding toys); rim blocks (toilet); scent beads; shoe polishes; toilet gel.
